

## SERVICE PROVIDER ACH ENROLLEMENT FORM

All service providers are encouraged to electronically submit invoices, in PDF format, directly to our accounting department, via email, at <a href="mailto:AccountsPayable@NRPartnersLLC.com">AccountsPayable@NRPartnersLLC.com</a>. This eliminates the need to process an invoice, pay for postage and wait for mail delivery! When submitting, please send only one invoice per email for the most expeditious processing.

Additionally, we offer the option of receiving payments via an electronic funds transfer, again, at no cost to you. Payments will be electronically deposited into your company's designated bank account through ACH (Automated Clearing House). ACH payment remittance advice will be delivered via email to the primary email address on file.

To enroll in ACH payment, simply complete and return the attached form.

Signing up for ACH payments provides several benefits:

## **Quicker Payments**

- ✓ ACH payments are a faster method of payment.
- ✓ ACH payments can be credited to your account in just a few days. Payments made by check can take 7-10 days to be received through the postal service.
- ✓ Usually, banks do not hold ACH payments unlike the checks you deposit. Your funds are available as soon as the ACH payment is credited to your account.

- ✓ ACH payments eliminate the need for paper checks.
- √ Your ACH payment cannot be lost in the mail or delayed due to a forwarded address.
- ✓ You will receive notification and remittance advice for each ACH payment via email.
